

#### Indian Street-Working Children

Indian Children in Street Situations (ICISS) are defined as Indian children whose world and livelihood depends upon what they can obtain in the streets.

The term "child labour" or Working Children is often defined as work that deprives children of their childhood, their potential and their dignity, and that is harmful to physical and mental development.

#### Indian Underprivileged Children

Underprivileged children are those who lack access to basic needs, opportunities, and resources essential for their overall development and wellbeing.

#### Indian School Dropout Children

The term school dropout children refers to children who discontinue their education before completing the grade or level of schooling they are expected to finish, according to their age and educational system. This usually involves leaving formal education permanently or temporarily without graduating or achieving the minimum educational qualification.

#### Problems of Vulnerable Children

- 1. **Poverty:** Poverty is a major challenge for street-working, Underprivileged and School dropout children.
- Lack of Safe Shelter: Safe shelters for above mentioned children are vital spaces that provide protection, care, and stability for vulnerable young individuals. These shelters serve as sanctuaries for children who may face abuse, neglect, homelessness, or other challenging circumstances, offering them a supportive environment to thrive physically, emotionally, and mentally.
- 3. Health and Nutrition Issues: Proper nutrition and healthcare during early childhood prevent malnutrition and diseases, ensuring healthy growth.
- 4. Lack of Education: Early childhood education lays the foundation for cognitive development, creativity, and lifelong learning. Access to quality schooling is essential for a child's future success.
- 5. **Emotional Support:** Creating a nurturing environment with love, care, and guidance promotes emotional stability and resilience in children.

- 6. **Violence:** Street children are often exposed to physical and moral violence, including bullying, sexual violence, and street fights.
- 7. **Substance abuse:** Street children are at risk of developing substance abuse issues, such as alcoholism and drug addiction.
- 8. **Mental health:** Street children may suffer from mental health problems due to chronic exposure to violence, abuse, and neglect.
- 9. **Family instability:** Family instability can contribute to children ending up on the street.
- 10. **Social exclusion:** Street children may face social exclusion and harassment.
- 11. Sexual exploitation: Child sexual abuse refers to sexual activities committed against children, by adults or peers and usually involves an individual or group taking advantage of an imbalance of power. Force may be used, with offenders frequently using authority, power, manipulation, or deception.
- 12. Gender discrimination: It means any exclusion or restriction made on the basis of gender that creates barriers for girls, boys, women in recognizing, enjoying or exercising their full and equal human rights.
- 13. Child Labor and Exploitation: Despite laws prohibiting child labor, millions of children are engaged in hazardous work to support their families. Children in bonded labor, domestic work, and informal sectors are at risk of exploitation and abuse.
- 14. **Child Marriage:** Child marriage persists in many regions, particularly in rural areas, with girls being married off before the legal age of 18. Early marriages hinder educational opportunities, increase health risks during childbirth, and perpetuate cycles of poverty.
- 15. Child trafficking and Abuse: India is a source, transit, and destination country for child trafficking, with victims exploited for labor, sexual exploitation, and forced begging.

#### Solution of Problems faced by Vulnerable Children

Street children face numerous challenges, including lack of shelter, food insecurity, limited access to education and healthcare, and exposure to abuse and exploitation. Addressing these problems requires a multi-faceted approach involving **Government of India**, **Government of West Bengal**, Mukhopadhyay Foundation, Communities, Corporate House through CSR and individuals. Here's a brief solution framework is given below:

#### 1. Secure Shelter and Basic Needs: through "Sai Niwas" a Hostel for both Sexes

"Sai Niwas" solve the safe shelters that provide food, clothing, and hygiene facilities. "Sai Niwas" also develop long-term housing solutions for reintegration into society.

#### 2. Access to Education through "Swami Vivekananda International School"

- a) Primary to Higher Secondary School: Provide Primary to Higher Secondary education.






Figure shows the strategy of the Proposed project
